**2025 Membership:** MRC dues are \$50.00 new member and \$45.00 renewal. New members must be sponsored. Auxiliary dues are \$30 and renewal is \$25.00.

**MRC Application for Membership:** When sponsoring a new member, our Bylaws require the sponsor and applicant to attend the membership meeting so the new applicant can be voted on.

**Volunteers:** As a private Club, we rely on our volunteers! **Please be reminded that all new members MUST volunteer at the Club on two different occasions within the first 12 months of membership.**

**Club Decorum:** We ask that all members practice discretion while using the Club facilities. Please try to control loud foul language (especially when we are open to the public).

**Attention Members:** **NO ANIMALS** are allowed inside the Club (Health Department rules). The only exception is a certified service animal.

**MRC Hours:** Sunday, Noon-11:00PM. Monday-Wednesday, 3:00PM to 11:00PM. Thursday, 2:00PM-11:00PM. Friday, 2:00PM-Midnight. Saturday, Noon-Midnight.

**Liquor Price Changes:** effective March 1<sup>st</sup>. Top shelf liquor (all except well liquor), wine, seltzers and premium beers will have a \$.25 increase. Domestic beers and well liquor will remain the same on non-discounted days.

Thursday specials will increase from \$2.00 to \$2.25. Sunday will increase from \$2.25 to \$2.50. An updated price list will be posted behind the bar.

The Club has absorbed multiple cost increases for the last two years and just received notices of more increases coming. The last increase was March 2023.
